



## **“Holder’s Reward” Terms and Conditions**

### **1. Introduction**

**1.1** These terms & conditions set out the terms between you the user and us the website <https://reward.leocoin.org>, which service/s allows the user to register LEOcoin token address(es) in order to participate in the “LEOcoin Holder’s Reward” (LHR) according to the rules of the entire website. The page may be used to register multiple LEOcoin token addresses.

**1.2** Your use of this website and any service contained within constitutes acceptance of these terms & conditions in full.

**1.3** You should not use this website if you do not accept these terms & conditions in full.

### **2. “Holder’s Reward” Information and Rules of Use**

**2.1** You should always check that the address information you provide is correct and belongs to you before registering for LHR. You agree to provide complete and accurate information about your address(es) and keep yourself updated using the Status URL provided on-screen after you enter a valid LEOcoin token address in the first page of <https://reward.leocoin.org>.

**2.2** You are responsible for registering only LEOcoin address(es) that you have full access to their private keys, meaning you own the Ethereum wallet that holds the address(es) registered.

**2.3** You are responsible for checking the progress of your rewards, as they appear using your unique Status URL, and inform LEOcoin support for any issues regarding your rewards within three (3) working days after the LHR is updated as per your Status URL page, at the start of each month, usually the 1<sup>st</sup> of the month. After the three (3) working days, we will assume that the amount of LHR that is to be credited to your registered address(es) is correct and you forfeit the right to raise any objections thereafter.

**2.4** The LHR is paid out once a month to all the eligible addresses that have been registered at least one (1) working day before the last day of each month. It is possible that we might decide to change the frequency of LHR payments in the future.

**2.5** "Eligible" is any LEOcoin token address that holds a monthly average of at least 1,000 LEOcoin Tokens on the 1<sup>st</sup> of each month, counting back all the days of the previous month.

**2.6** Depending on your country of residence, you may not be able to use all our services. We are not responsible if you don't follow the rules and laws of your country of residence.

**2.7** You agree not to use our service to perform criminal activity of any kind, especially money laundering, terrorist financing, illegal gambling, or fraudulent hacking.

**2.8** There is no way for a registered address to stop receiving LHR if the system finds it eligible for it. The only way for an address not to receive LHR is if the monthly average of all the days in the previous month is below the minimum amount required for LHR, as per the **Table of Rewards and Requirements for LHR**.

**2.9.** The LHR payments follow the standard compound interest formulae. The estimated annual LHR with examples is explained in the **Table of Rewards and Requirements for LHR**.

**2.10.** There is no need for any Ethereum wallet that holds your LEOcoin tokens to be online to receive the LHR. LHR is paid-out to the eligible address(es) even if your wallet is offline.

**2.11.** There is no cost of any kind for any address(es) to register for the LHR.

### 3. Privacy

We take your privacy seriously. We do not ask nor hold any private information other than what is necessary for the LHR to operate for each registered address. We may, therefore, keep the following information in our databases, in various periods like daily, weekly, monthly or otherwise:

- LEOcoin addresses
- Date address(es) was registered for LHR
- Amount of LEOcoin Tokens in the registered address(es)
- Block numbers
- Transaction Hashes
- LHR rewards
- Details of Transactions like inbound transfers, outbound transfers, token transfers, LHR amounts, and more data related to each address(es) registered for LHR

In case you provide an email when registering an address, we also keep it in our databases linked to your registered LEOcoin Token address, so that we may contact you about LHR or other future services and KYC related updates.

## 4. Customer Complaints

We endeavor to respond to all complaints or queries within five working days, that is sent via the online form, or the email included in the support page.

## 5. Events Outside our Control

We shall not be liable for delay or failure to perform any obligation under these terms & conditions if the delay or failure is caused by any circumstances beyond our reasonable control, including, but not limited to, acts of God, war, civil disorder or industrial dispute.

## 6. License

**6.1** We grant you a license to access the content, information, and services contained within our website for personal use only.

**6.2** This license allows you to download and cache (using your browser) individual pages from our website.

**6.3** This license does not allow you to download and modify individual pages or substantial parts of our website nor to make our website available via an intranet, where our website or a substantial part of it is hosted locally on the intranet in question.

**6.4** Our website design, layout, content, or text cannot be copied, edited, or otherwise manipulated without our express prior written permission.

**6.5** Our website cannot be placed within the frame-set of another site.

**8.7** These terms and conditions do not exclude or limit liability for fraud or fraudulent misrepresentation caused by you or us.

**8.8** These terms and conditions do not exclude or limit liability where this conflicts with the applicable law for this jurisdiction.

**8.9** Our services are provided without warranty of any kind on a "As Is" and a "As Available" basis. We do not guarantee that the services or the website will be available at any time. The use of the website may be suspended for maintenance.

## 9. Indemnity

By your use of our website or service/s you hereby indemnify us and undertake to keep us indemnified at all times now and in the future against all possible claims relating to any breach of these terms and conditions by you. ## 16. Table of Rewards and Requirements for LHR

Users that want to participate in "LEOcoin Holder's Reward" must own a minimum amount of 1,000 (one thousand) LEOcoins on a specific LEOcoin token address. The Reward returns depend on the number of LEOcoin tokens you hold in that address. The system will be keeping daily snapshots of your total LEOcoin tokens in your address throughout the month. Your Reward will be calculated

based on the average of all these snapshots. The "LEOcoin Holder's Reward" will be credited after the first five (5) working days of each month to your LEOcoin token address.
